Participation terms and conditions

As part of the School Recycling Education Program, the participating school will agree to the following:

1. The City of Bayswater will provide a specified number of recycling and FOGO bins, free of charge, based on the number of students currently enrolled. The free service is provided to promote the correct methodology of waste disposal and recycling.
2. The school agrees to continue to participate in waste and environmental education programs provided or organised by the City of Bayswater. This may be up to once per year.
3. The school agrees to participate in waste audits and site visits, to be undertaken by the City of Bayswater or an authorised party, to assist in gathering data about usage of the bins provided free of charge. This may be to gain further understanding about future education requirements, or used to provide advice to the school about possibilities of reducing waste charges through the proper use of the bins.
4. The school understands that the bins provided free of charge by the City of Bayswater are intended to divert food waste from landfill, and educate staff and students about using the three-bin FOGO system. The bins provided free of charge are not intended for use by gardeners / groundskeepers, and should not be used as additional capacity for green waste.
5. The City of Bayswater can remove bins at any point (with notice given) if changes are made to the Common Use Agreement (CUA) for waste. Bins can be provided free of charge as an exemption to the CUA as they are used as an education tool for students. Direction from the

Department of Education and Department of Treasury and Finance will stipulate future actions taken.

6. The school understands that it is the responsibility of the school to arrange for the relevant bins to be presented to the verge for collection on the normal collection day for the area. The normal collection day can be found by visiting bayswater.wa.gov.au/bins

Number of bins provided*

1 – 100 students	1 x FOGO bin, and 1 x recycling bin
101 – 200 students	2 x FOGO bins, and 2 x recycling bins
201 – 300 students	3 x FOGO bins, and 3 x recycling bins
301 – 400 students	4 x FOGO bins, and 4 x recycling bins
401 – 500 students	5 x FOGO bins, and 5 x recycling bins
501 – 700 students	6 x FOGO bins, and 6 x recycling bins

* This is intended as a guide, and the number of bins can be negotiated with the City after three (3) months of having the bins onsite. Please contact the City’s Waste Education Officer at 9272 0964 or fogo@bayswater.wa.gov.au.

General waste bins can be considered as part of this program, and will be provided subject to the bin location and opportunity for usage by students. A site visit can confirm viability of this.
