# Pearl Chaloupka - Written Deputation

Item 10.4.3 Proposed Event Permit for Peninsula Farm – Reserve 35112, 2CJohnson Road, Maylands.

Ordinary Council Meeting Tuesday 25 January 2022 commencing 6:30pm.

I am a Ballardong, Noongar woman who lives

On 9<sup>th</sup> October 2021, Anne Gaunt found a Noongar artefact a handful of metres beside WuRutt Woorat. She left it in situ and called me to show me where she found it.

I consulted was John Stanton, Social Anthropologist and former Director of the Berndt Museum. He believes that despite the amount of development that has occurred in thearea, other significant artefacts could be the area including middens.

I have since consulted with academics who agree that it is a Noongar artefact. I then consulted with Annie Carson WA Museum Boola Bardip. She offered that if the artefact is housed with the Museum it can be held in custodial care. This would mean that it could be returned to the Noongar Nation if required. A decision about where the artefact will be displayed and housed will be made at a later date after further consultation with Noongar Elders.

Annie Carson also highlighted that Department of Planning Lands and Heritage needs to review any permits for activity in the area as it is already a heritage area. This includes theworks that are pictured occurring in the below photo of where the artefact was found.

Dr Noel Nannup has looked at photos of the artefact and said that Noongar people used toknock down the insulation glass on old telegraph lines to make tools from the glass. He showed me how the pictured cutting tool would have been held.

Barry McGuire, Noongar Elder is being kept in the loop about the artefact and its significance to the area. Carol Foley is also being keep up-to-date. She is also a Noongar Elder and has conducted Welcome To Country at Wu Rutt Woorat for the WA National Trust(the Trust) for years. Also

Notably, Anne Gaunt's ancestor was a manager of the farm. This makes the site and the discovery of the artefact particularly meaningful for her.

Important environmental works will be conducted on the foreshore around and on Wu Rut Woorat. This can't go ahead without Noongar consultation and archaeological oversite. Also of concern are statements by Julian McDonald, CEO of the Trust at the Maylands Residents and Rate Payers Association meeting of 8 March 2021.

He flagged plans to build a commercial jetty at Wu Rut Woorat a short distance from an existing public jetty. An early version of the Trust's plans for the site show the commercialjetty. He also spoke of plans for up to 100 commercial events at the site. Both of these grandiose plans have been pulled back for now but there is nothing stopping from them arising again. As a result, a feeling of distrust and unease still remains especially as the latestevent submission did not identify a cap on the number of commercial events. As these events are not going to be attended or supervised by the Trust they will not be able to commit to no environmental or cultural impact on the site.

#### Recommendation

That Wu Rutt Woorat (Peninsula Farm) is not used for any commercial events.



# Dear Councillors,

Baigup Wetlands Interest Group members are aware that the first agenda for the year includes discussion of our petition. We confirm that our group is strongly in favour of 'Option 1', transfer

of the management order of the eastern land portion of Baigup Wetlands to the City of Bayswater. Thank you.

# Benefits of bringing whole of Baigup under City of Bayswater management:

Baigup Wetlands is a valuable high-use community asset. Given existing intersecting infrastructure realities and responsibilities (walk/cycle path, sewer, gas pipeline) it makes sense for the City to manage the reserve as a unified whole. Previous concerns about legacy issues are appropriately and realistically addressed in the Officer's recommendations.

# Efficiency:

Economies of scale, unified management approach, single restoration policy.

# Amplify community participation:

Community participation (weeding, planting) under City direction is currently restricted to only 1/3 of the total reserve. Baigup Wetland Interest Group has 260 newsletter subscribers, 676 facebook followers, and 95 twitter feed followers. Interest and support will increase with greater access and involvement across the whole reserve.



#### Enhanced status:

Unification will bring WAPC land into existing Crown Reserve 24708 allowing possibility of conversion to A Class Reserve. Currently the City has only one A Class Reserve at Lighting Swamp.

#### 'Featured Treasure'

Baigup is recognised as a <a href="IFeatured Treasure">IFeatured Treasure</a> on the Urban Bushland Council website. The City cannot currently celebrate this as the bulk of the reserve is in WAPC land managed by DPLH. The <a href="Baigup Wetlands page">Baigup Wetlands page</a> includes 82 bird species photographed at Baigup (total 96 officially recorded by Birdlife WA).

# National recognition

Baigup's extensive sedge plains are registered as a valuable example of Temperate Coastal Saltmarsh Threatened Ecological Community. The most intact and healthy sections are on the WAPC land.

# Community Strategic Plan performance measures:

Activities in the eastern 2/3 of Baigup can contribute under unified management: e.g. a current BWIG riverbank repair grant administered by DBCA on the WAPC land. The value of collective specialist knowledge held by BWIG members to the City is enhanced. For instance, current hydrological stability and potential acid sulphate soils management on the WAPC land was achieved by BWIG in consultation with government experts using grant funding.

How best to preserve Baigup Wetlands than to bring it wholly into CoB Management with a view to creating an 'A Class' Reserve?
