Proposed Naming of Maxwell Reserve (Reserve 33533) to Pittaway Park

The City of Bayswater hereby gives notice that Council at its Meeting held on 24 September 2024 adopted the proposed reserve name for public advertising.

It is proposed to rename 'Maxwell Reserve' to 'Pittaway Park' in commemoration of the achievements of Graham Pittaway, who was part of a range of local committees and community groups and received an OAM for his services. 'Maxwell Reserve' has been selected for formal naming, as its current name is not official and is not recognised by Landgate's Geographic Names Committee.

A plan depicting the location of the reserve can be inspected between 8:30am and 4:30pm, Monday to Friday up to and including **Monday 25 November 2024** at the City of Bayswater Civic Centre, Bayswater Library or on the City's Website: engage.bayswater.wa.gov.au.
