Application for Approved Cat Breeder Licence

PRIVACY AND COLLECTION NOTICE

The City of Bayswater collects personal information, including sensitive information where applicable, for the purpose of assessing, determining, administering and monitoring an application for an Approved Cat Breeder Licence.

Personal information is collected under the authority of the Cat Act 2011 (WA), Cat Regulations 2012 (WA), and the City's functions as a local government, and is used to assess eligibility, issue and administer Approved Cat Breeder Licences, maintain statutory records, and fulfil legislative obligations.

The types of information collected include the applicant's name, residential and postal address, contact details, proof of identity, property details, cat registration and microchip information, breeder registration details, supporting documentation, and information relating to convictions, infringements and regulatory compliance history where relevant to the application.

Personal information may be disclosed to relevant City officers, contractors, service providers, government agencies, regulators or other parties where authorised or required by law.

Providing this information is mandatory. If the requested information is not provided, the City may be unable to process the application or issue an Approved Cat Breeder Licence.

The City takes reasonable steps to protect personal information from misuse, loss, unauthorised access, modification or disclosure.

Information is retained in accordance with the State Records Act 2000 (WA), approved retention and disposal schedules, and the City's information management practices.

The City may use automated systems to assist with the receipt, storage, validation and processing of application information. Any decision to approve, refuse, suspend or cancel an Approved Cat Breeder Licence is subject to review and authorisation by an appropriately authorised City officer.
